The balance of payment is due 20-30 days prior to your date of arrival. If your booking is made and confirmed within 45 days of your arrival date, full payment will be required immediately. Payments can be made either by a Telegraphic /Swift Transfer to our bank account

The following penalties will apply:-

- Cancellations received between 35 days and 25 days prior to commencement of Services shall be
 Charged at 25% of the total cost of Services.
- Cancellation received between 24 days and 15 days (48hours) prior to commencement of Services
 Shall be charged at 35% of the total cost of Services.
- Cancellation received between 14 days and 08 days (48hours) prior to commencement of Services
 Shall be charged at 50% of the total cost of Services.
- Cancellation received between 07 days and 03 days (48hours) prior to commencement of Services
